The successful applicant will have the ability to differentiate and challenge all learners' ability levels. Group sizes can vary between 15 – 30 learners whose ages range between 16 and 19 years old. As an Animal Care Tutor/Assessor you will help learners to think about their futures and provide some focus on accessible career paths, whilst creating progression opportunities for both further work-based learning and employment.

The role is predominately based at ACT's Hadfield Skills Centre, however, frequent cover across other centres is to be expected, dependent on learner need.

The Animal Care Tutor fits within the JGW+ department reporting to the Animal Care Sector Lead.
